**Terms:**

1. I agree to pay a non-refundable annual use/maintenance fee of **\$50 (\$25 in 2011-12)** on or before taking possession of the iPad-2 and its accessories (i.e., protective case and charger/sync cord).
2. I agree to create and maintain an iTunes account and accept responsibility for any purchases made through it.
3. I agree to practice digital citizenship and responsible social networking.
4. I agree to comply at all times with the Florence School District's Acceptable Use Policy and iPad-2 Procedures Manual incorporated herein by reference and made a part hereof for all purposes. Any failure to comply may terminate my rights of possession effective immediately, and the school system may repossess the iPad-2 and its accessories.
5. I agree that I will not deface the iPad-2 or its accessories in any way, including the addition of decals, markings etc.
6. I understand that I will be assigned the same iPad-2 each year that they are issued.
7. I agree that I will not alter (i.e. "jailbreak") the iPad-2, nor software configuration or functionality installed by Apple and Florence City Schools.

**Title:**

Legal title to the iPad-2 and its accessories is in the name of Florence City Schools and shall at all times remain so. My right of possession and use is limited to and conditioned upon my full and complete compliance with this Agreement, the Acceptable Use Policy and the iPad-2 Procedures Manual.

**Loss or Damage:**

If the iPad-2 is damaged, lost or stolen, I am responsible for the **\$50 (\$100 in 2011-2012)** insurance deductible. This plan will include one replacement. Additional replacements will cost me or my parent/guardian the full value of an iPad-2 (approx. \$500). I agree to report the loss or theft of the iPad-2 and/or its protective case to the school within 24 hours of occurrence.

NOTE: Seniors must clear all records and pay all fees before participating in graduation ceremonies.

**Repossession:**

If I do not timely and fully comply with all terms of this Agreement, including the timely return of the iPad-2 and its accessories, the school system shall be entitled to declare me in default and come to my place of residence, or other location of the iPad-2 and its accessories, to take possession of the iPad-2 and its accessories.

**Term of Agreement:**

*My right to the use and possession of the iPad-2 and its accessories terminates not later than the last day of the school year unless earlier terminated by Florence City Schools or upon my withdrawal from the Florence City Schools.*

**Appropriation:** *My failure to timely return the iPad-2 and its accessories and my continued use of it without the school system's consent may be considered unlawful appropriation of property that legally belongs to Florence City Schools.*
